Education Recruiter as a Data Controller

When using your personal data, Education Recruiter is often a "Data Controller". This means that we are responsible for deciding how we hold and use your personal data.

You may also authorise us to share your information with other organisations e.g. with a recruiter when you use our platform to apply for a role.

In these cases, those organisations are Data Controllers in their own right and their use of your information will be governed by their privacy policies.

If you are not sure, you have the right to ask us – at any time – who we may be sharing your personal data with. You can also revoke your consent to share with other Data Controllers by revoking their access to your information in the settings area of your profile or by contacting us at mydata@education-recruiter.com.

When do we collect your personal data as a Data Controller?

- When you create an account on the Education Recruiter website;
- When you choose to synch your Education Recruiter account with your AoC jobs account;
- When you use your account to search or apply for roles;
- When you add CVs or other information to your account.

What personal data do we collect?

The amount of information we collect about you depends to a great extent on how you use your Education Recruiter account and make use of additional functionality within the platform e.g. by using the facility to extract information from your CV to add additional detail to your profile.

The table below sets out the main categories of personal data we collect although this may not be an exhaustive list.

Biographical Data	<p>This is mainly information about your education and employment history such as your qualifications and previous employment details.</p> <p>This information can include financial information such as your salary history.</p> <p>Depending on how you use the Education Recruiter platform, we may also gather information about your habits and activities.</p> <p>This is information you add to your profile which may include details of your extra-curricular activities and other life events.</p>
Special Categories Data	<p>This is data about your racial or ethnic origin, health data, sex life or sexual orientation, political opinions or affiliations, religious or philosophical beliefs, genetic or biometric data such as photographs which are used to identify you.</p> <p>We do not ask for or need any of this type of data, but you can choose to populate your profile information which may indirectly reveal some of this information.</p> <p>These include providing information about your right to work in the UK, courses you have completed which have been run by unions and any photographs you choose to add to your profile.</p> <div data-bbox="563 1675 1377 1917" style="background-color: #f0f0f0; padding: 10px;"> <p>Please be aware that you make this data available to recruiters if you choose to upload a CV which contains this type of information. Please ensure your CV and profile contain only information you are happy to share with recruiters who may view your profile before you upload it.</p> </div>
Technical Data	<p>Your IP address, browser type and version, session ID, time zone setting, browser plug-in types, geolocation information, operating system and version.</p>

	<p>The pages you visit, the path you take through our site, page load times, errors you receive, how long you stay on our pages, what you do on those pages, how often, details of jobs viewed or applied for and any search terms you entered etc</p> <p>This information is normally gathered using cookies in your web browser.
